Members

During the period under review 7 (2009/10: 12) new members were elected and, after taking into account deaths, resignations and lapsed members, the membership stood, as at the date of this report, at 393 (2009/10: 402). The total comprised 4 (2009/10: 6) Honorary members; 340 (2009/10: 345) Ordinary members; 8 (2009/10: 8) Family members; 4 (2009/10: 4) Associate members and 37 (2009/10: 39) Institutional members.

Personalia

The period under review saw the passing of four members:

Mrs. Rita Grimes, who passed away on 14th March 2011, joined the Society in 1974 and was elected an Honorary member in 1985. Mrs. Grimes was Hon. Assistant Secretary from 1977 to 1985.

The other members who have passed away are: Richard Denyer (2005), Geoffrey North (1975) and Rev. J W Trevor Rogers (1994).

Meetings

Two General Meetings of the Society were held.

The first was held at the Wallace Collection on 13th November 2010 by courtesy of our member, Toby Capwell, Curator of Arms and Armour, who spoke on *The Depiction of Armour on Monumental Brasses: Style Context and Meaning*. The presentation was a tribute to our late Vice-President, Claude Blair. The afternoon concluded with a guided tour of the three galleries devoted to arms and armour including a rare opportunity to view (at close quarters) the brass comprising the feet and (uncrossed) legs of a man in armour of French origin, dated c.1325.

The second General meeting was held on 2nd April 2011 by special arrangement at Islington church and those dedicated to St. James and St. John at Clerkenwell. On arrival at Islington parish church, the morning comprised a welcome by our President, David Meara. Our member, Derrick Chivers followed with a short presentation relating to the chequered history of the building and brasses. After lunch, members proceeded to the Priory Church of St. John at Clerkenwell where a guided tour included the remarkable 12th century rib-vaulted crypt. The day concluded with a visit to the church of St. James, Clerkenwell. The incumbent, Andrew Baughen provided a welcome followed by Derrick Chivers who focused on the brass commemorating John Bell, Bishop of Worcester, 1556.

The Annual General Meeting was held in the Becket Chapel, located in precincts of Peterborough Cathedral, on 10th July 2010. Following the formal business our member, Rob Kinsey spoke on Lawyers and Stewards on Brasses in Peterborough Cathedral. The Chapel was adorned with brass rubbings displayed by our members, Derrick Chivers, Jane Houghton and Janet Whitham.

A joint meeting with the Church Monuments Society was held at the Victoria & Albert Museum on 12th February 2011 to celebrate the life and work of our late Vice-President, Claude Blair. After lunch, our Vice-President, Nigel Saul spoke on the Brass of Sir Thomas and Lady Walsh at Wanlip, Leicestershire; our member, Julian Luxford on The Hastings brass at Elsing: a contextual analysis; our Hon. Editor and Vice-President, Nicholas Rogers on "A tablet of Antick facon": The Introduction of Classical Motifs in Monumental Brasses; and finally our Vice-President, Paul Cockerham on 'Cathédrale Ou Collégiale?: Monuments and Commemoration In Late Medieval Toul'.

Study Day

A Study Day was held at Long Melford, Suffolk on 25th September 2010. Proceedings were opened in the church by our member, Rupert Webber who spoke on *Bonds of Brass: The Obligations of John Clopton at Long Melford*. Our members, David Griffith and Rachel Canty contributed a talk entitled *The Church as Book: Fifteenth Century Devotional and Meditational Texts in the Clopton Chapel* with a tour of the church concluding the morning. The afternoon session was held in a conference room at the Bull Hotel where Richard Marks (Hon. Professor of the History of Art at the University of Cambridge) spoke on *John Clopton: Commemoration and Devotion at Long Melford* with Anna Eavis (Head of National Monument Record Services at English Heritage) contributing *Reading the Windows at Holy Trinity, Long Melford*. Finally, our member, John Blatchly spoke on *Roger Martin of Melford: Eight-eight years on the religious roller coaster from 1527*. Tea rounding off proceedings. The day was chaired by our President, David Meara and our Vice-President and Hon. Secretary, Martin Stuchfield. The Study Day was organised by our member, Christian Steer and Martin Stuchfield (who also acted as Registrar).

A Study Day was also held at St. George's Chapel, Windsor on 4th June 2011. The morning was occupied with an organised tour of the chapel by the Guild of Stewards followed by delegates taking advantage of the opportunity to view the wealth of monuments, brasses etc. at their leisure. The afternoon session was held in Vicar's Hall where our member, Clive Burgess and David Lewis spoke on St. George's Chapel and Medieval Windsor followed by our Vice-President, Jerome Bertram on The Canons of St. George's Windsor and their Brasses and Lesley Boatwright on The Monument as Propaganda: Publicising the Miracles of Henry VI. After tea, our Vice-President and Hon. Editor, Nicholas Rogers, spoke on The Chantry Foundation Plate of Anne of York and Sir Thomas St. Leger. Finally our member, Tim Tatton-Brown spoke on The Tomb of Henry VIII. The day was chaired by our President, David Meara and our member, Christian Steer. The day was organised by Christian Steer and our Vice-President and Hon. Secretary, Martin Stuchfield (who also acted as Registrar).

Publications

The period under review produced a further issue of the *Transactions* for the year 2009 (Volume XVIII, Part 1) under the editorship of Nicholas Rogers.

The Hon. Bulletin Editor, William Lack, was responsible for three issues of the *Bulletin* (115, 116 and 117).

Website

Independent Examiner's Report

for the year ended 31st December 2010

To the trustees/members of the Monumental Brass Society

This report on the accounts of the Monumental Brass Society for the year ended 31st December 2010, which are set out on pages 9 to 11, is in respect of an examination carried out under section 43 of the Charities Act 1993.

Respective responsibilities of trustees and examiner

As the charity's trustees you are responsible for the preparation of the accounts; you consider that the audit requirement of section 43(2) of the Charities Act 1993 ('the Act') does not apply. Basis of independent examiner's report
