In addition, Jane held office as Hon. Archivist from 1997 to 2012 when, upon retirement, she was appointed as an Honorary Member of the Society. She has made a major contribution to the *County Series*, particularly the volumes covering the counties of Dorsetshire and Huntingdonshire, which have been dedicated to her. She is currently working in earnest on the Northamptonshire volume.

## Trustees' report 2016/17

The Trustees present their report and accounts for the year ended 31st December 2016. The Trustees who served during the year and up to the date of this report are set out on page 1.

### **Structure, governance and management**

The Society was founded in 1887 as the Cambridge University Association of Brass Collectors and renamed as the Monumental Brass Society on 1st January 1894. The Society went into abeyance from 1st December 1914 until its revival on 6th February 1934. It is governed by a Trust Deed dated 1st April 1967 and was registered with the Charity Commission on 27th November 1967. H.M. Revenue & Customs has accepted the Society as a Charity within the definition of section 506(1) of the Income and Corporation Taxes Act 1988, as a result of which the Society's income and gains are not taxable to the extent that they are applicable and applied to charitable purposes.

The affairs of the Society are managed by an Executive Council ("the Trustees") of which all the officers (President, Vice-Presidents, Hon. Secretary, Hon. Treasurer, Hon. Editor) are members in addition to six ordinary members. The latter serve for a period of three years with two such members retiring by rotation each year. No person retiring is eligible for re-election at the same meeting. Nominations to fill vacancies on the Executive Council, duly proposed and seconded by two members of the Society and indicating the willingness of the nominee to stand must reach the Hon. Secretary by not later than 7th June each year. The officers of the Society and members of the Executive Council are elected at the Annual General Meeting. The Trustees have the power to fill vacancies occurring amongst the officers till the next Annual General Meeting and to co-opt such additional members as in their judgement are necessary.

The Trustees normally meet three times each year to consider grant applications and to conduct the business of the Charity.

The Trustees have assessed the major risks to which the Society is exposed and are satisfied that systems are in place to mitigate exposure to the major risks.

### **Objectives and activities**

The Society's objects are:

- (a) To endeavour to ensure the better preservation of monumental brasses, indents of lost brasses and incised slabs;
- (b) To promote the study of, and interest in, monumental brasses, indents and incised slabs by the publication of transactions and in any other way possible; and
- (c) To compile with a view to publication a list of all extant brasses, indents and incised slabs, both British and foreign.

The Trustees have paid due regard to the guidance issued by the Charity Commission in deciding what activities the Society should undertake.

### **Achievements and performance**

#### ***Members***

During the period under review 1 (2015/16: 16) new member was elected and, after taking into account deaths, resignations and lapsed members, the membership stood, as at the date of this report, at 391 (2015/16: 406). The total comprised 5 (2015/16: 5) Honorary members; 337 (2015/16: 347) Ordinary members; 11 (2015/16: 12) Family members; 8 (2015/16: 12) Associate members; and 30 (2014/15: 30) Institutional members.

### Achievements and performance (continued)

#### *Personalia*

The period under review saw the passing of four members: John Dobson (1972), Peter Hacker (1986), Ian Pettman (1958) and Robert Thorogood (1976).

#### *Meetings*

Three General Meetings of the Society were held.

The first General meeting, by way of innovation was held mid-week, on Wednesday, 21st September 2016, by special arrangement, at The Grange (a Landmark Trust property and the former home of Augustus Welby Northmore Pugin) and the church dedicated to St. Augustine of Canterbury at Ramsgate, Kent. Proceedings were opened by Catriona Blaker, of the Pugin Society, who provided an introductory talk and a tour of the house. Members proceeded afterwards to the adjacent church where David Meara provided an introductory talk with particular emphasis on the collection of Victorian brasses. The afternoon concluded with tea at the nearby St. Augustine's Monastery, now a Vincentian Retreat Centre, where Jerome Bertram spoke on the *Medieval Brasses of Thanet*. In addition, members received an illustrated booklet which had been written and produced by David Meara. The meeting was organised by our Vice-Presidents, Jerome Bertram and David Meara.

The second was held on 5th November 2016, by special arrangement, at the London church of St. Bartholomew-the-Less. Following a welcome by the President an introductory talk was provided by Rev. Martin Dudley, incumbent of the combined benefices of St. Bartholomew in the City of London. Sheila Sweetinburgh, Elma Brenner and our member, Sophie Oosterwijk spoke on *Gift Giving and the Art of Commemoration at English Medieval Hospitals; An introduction to the Wellcome Library and its early collections;* and *Untimely ripped: Childbirth and Child Death on Brasses* respectively. Our Vice-President, Stephen Freeth, gave a brief and informal introduction to the monumental brass depicting William Markeby, 1439, and his wife (M.S.I). Tea (organised by Janet Whitham) rounded off proceedings. The meeting was organised by Jessica Barker and the Hon. Secretary.

The third General meeting was held on 8th April 2017, by special arrangement, at the York church of All Saints North Street. Following a welcome by the President an introductory talk was provided by Emma Woolfrey. Our member, John Roberts spoke on *Tanning and civic responsibility in York on the eve of the Civil War: the brass of Thomas Atkinson, 1642* followed by John Richards (churchwarden) who spoke on *The Tomb in the Lady Chapel: three men and a pregnant lady* and Emma Woolfrey on *A history in glass: the windows of All Saints North Street*. In addition, members received a lavishly illustrated booklet entitled *Brasses and slabs in York: a brief preview* which had been written and generously produced by our Vice-President, Jerome Bertram. The meeting was organised by the Hon. Secretary.

The Annual General Meeting was held at St. Faith's Parish Hall, Back Street, Winchester on 16th July 2016. Following the formal business, John Crook spoke on *A Brief History of St. Cross Hospital*. The afternoon concluded with a tour of the Hospital of St. Cross and Almshouse of Noble Poverty including the chapel, under the direction of John Crook.

#### *Study Day*

A Study Day was held at Exeter Cathedral on 28th May 2016. Proceedings were opened with a welcome by the President followed by Nicholas Orme who spoke on *Where Shall I be Buried?*. Our member, Tobias Capwell contributed *Filling the Gaps: The Brass of Sir Peter Courtenay and the Monumental Representation of Armour*, with a tour of the cathedral to view the brasses, incised slabs and monuments concluding the morning session.

#### **Study Day** (continued)

The afternoon commenced with a talk by our member, David Lepine on *From Antiphons to Vigils: Commemorative Strategies at Exeter Cathedral*. Finally, our Vice-President, Paul Cockerham spoke on *Deans and Canons: Commemorative Contrasts across two Centuries*. Tea (organised by Janet Whitham) rounded off proceedings. The day was chaired by our President and organised by David Lepine (who also acted as Registrar).

#### **Publications**

The period under review produced one further issue of the *Transactions* for 2016 (Volume XIX, Part 3) under the editorship of David Lepine.

The Hon. Bulletin Editor, William Lack, was responsible for three issues of the *Bulletin* (132, 133 and 134).

#### **Website**

The website continued under the management of the Hon. Internet Publicity Officer, Jon Bayliss, and can be accessed at [www.mbs-brasses.co.uk](http://www.mbs-brasses.co.uk). However, a decision has been taken to commission a new website which is currently being built.

#### **Conservation**

In the matter of conservation of brasses the Society awarded the following grants:

For the financial period from 14th May to 31st December 2016:

Middlesex, Monken Hadley: £300 towards the conservation of four monumental brasses (LSW.II, III, IV and V);

Yorkshire, Brantingham: £260 towards the conservation of the monumental brass commemorating Anthony Smetheleye, esq., Lord of Brantingham, 1578 (M.S.I.);

For the financial period from 1st January to 13th May 2017:

Buckinghamshire, Amersham: £450 towards the conservation of four monumental brasses (LSW.II, III, IV and V).

The Conservation Fund was further augmented with the sum of £4,951 resulting from the 'Best of the Best Book Sale' which took place in July 2016, making a total of £8,490 resulting from the sale of the collection of books on brasses, monuments and allied subjects bequeathed to the Society by Peter Heseltine.

#### **Financial review**

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Charities Act 2011 and the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005. It is the policy of the Society that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between three and six months' expenditure. The Trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the Society's current activities while consideration is given to ways in which additional funds may be raised.

This level of reserves has been maintained throughout the year.

They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

## Notes to the accounts

for the year ended 31st December 2016

### 1. Accounting policies

#### 1.1 Basis of preparation

The accounts have been prepared under the historical cost convention modified to include the revaluation of certain fixed assets.

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005 and the Charities Act 2011.

#### 1.2 Incoming resources

Donations, legacies and other forms of voluntary income are recognised as incoming resources when receivable, except insofar as they are incapable of financial measurement.

Grants are recognised as incoming resources when receivable.

Membership subscriptions are recognised as incoming resources when received.

#### 1.3 Resources expended

These are recognised in the period in which they are incurred. Resources expended include V.A.T. which cannot be recovered. Governance comprises costs for the running of the charity itself as an organisation.

#### 1.4 Investments

Current asset investments are stated at market value.

#### 1.5 Foreign currency translation

Transactions denominated in foreign currencies are recorded at the rate ruling at the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. All differences are included in net outgoing resources.

## Independent examiner's report
